**INVITATION FOR EXPRESSION OF INTEREST/ TENDER**

The Directorate of Sikkim State Lotteries, Finance, Revenue & Expenditure Department, Government of Sikkim for and on behalf of the Governor hereby invites tenders/ bids from the eligible Proprietorship/ Partnership firms/Companies registered under the law for appointment of Marketing Agent for marketing and sale of **06 (Six) Online weekly lotteries per day (PART B) conducted by the State of Sikkim** under Lotteries (Regulation) Act, 1998 and Lotteries (Regulation) Rules, 2010 and Sikkim Online Lottery Rules, 2001 as amended.

The interested companies/firms may collect the Tender Document/Application Form from the Office of the Director, Sikkim State Lotteries, Government of Sikkim, Gangtok as per details given below: -

1. The Tender Document containing the prescribed application form and detailed terms and conditions of the tender shall be issued only to the Firms/Proprietorship /Companies registered under the law.
2. The Tenderer should be bonafide Marketing Agent(s)/Distributor(s)/Bulk Agents of sound financial standing having sufficient experience of at least 05 (five) years in the lottery business.
3. The Tenderer shall have carried out similar jobs (i.e. sale of Online Lotteries) continuously for 02 (two) or more years in the last 05 (five) years and should have distributorship of at least in one State currently.
4. The tentative date and time schedule of the tender is as follows.

The Tender Document may be obtained from the Office of the Director, Sikkim State Lotteries, Government of Sikkim, Deorali-737102, Gangtok on payment of a non-refundable amount of ₹ 2,00,000/- (Rupees Two Lakh ) only as application fee by Demand Draft / Pay Order to be drawn on any Scheduled/Nationalized Bank having its branch at Gangtok in favour of the Director, Sikkim State Lotteries, Government of Sikkim, Gangtok.
6. The tenure of distributorship will be for a period of 03 (three) years from the date of commencement of the first draw or till such period of the implementation of the notified amended Lottery rules of Ministry of Home Affairs, whichever is earlier.
7. The Directorate of Sikkim State Lotteries reserves the right to add/delete/modify the tender document.
