1. Sealed tenders are invited from interested person(s)/parties for auction of unsold paper lottery tickets (scrap materials) of the State Government of Sikkim.
2. The auction of the scrap materials will be "AS IS WHERE IS BASIS" and interested individual/party can inspect the scrap materials on working days during office hours at following addresses:
 1. P-2, Transport Depot Road, Kolkata- 700088
 2. P-41, Ground Floor, Hide Road Extension, Kolkata-700043
3. Interested individual/party may obtain the tender application form from the office of the Director, Sikkim State Lotteries, Deorali, Gangtok or the Office of Sikkim State Lotteries located at NO. 256/1, Madhabilata Abasan, Flat No. S1, Green Park Road, Kolkata-700133 during office hours w.e.f. 26th April, 2018 on payment of non-refundable amount of Rs. 2000/- only by Demand Draft/Pay order to be drawn on any Scheduled/ Nationalised bank having its branch at Gangtok in favour of Director, Sikkim State Lotteries. The tender application form is not transferable.
4. Bidder (s) may quote the rates per kilogram for the scrap materials both in figures and words (exclusive of any taxes and any other applicable charges). Any overwriting in rates or any change and /or alteration without attestation is liable for outright rejection of the tender. In case there is any error between the amount specified in figures and words, the higher of the two will be taken for consideration.
5. The tender application form along with the proof of identity should be accompanied by Earnest Money Deposit (EMD) of Rs. 50,000/- (Rupees fifty thousand) only by Demand Draft/Pay order to be drawn on any Scheduled/ Nationalised bank having its branch at Gangtok in favour of Director, Sikkim State Lotteries. The EMD so

- deposited shall be refunded to the bidder (s). No interest shall be payable on the amount of EMD for its retention by the Government of Sikkim during the bid period.
6. The tender application form with quoted offer accompanied by EMD and the required documents in a sealed cover should reach the office of the Director, Sikkim State Lotteries or Office at Kolkata on or before **17th May, 2018 by 4.00 PM.**
 7. The tenders shall be opened on **24th May, 2018 at 2. 00 PM** by the tender committee in the presence of the bidder(s) who may wish to be present.
 8. The successful bidder(s) shall make the payment within one week (7 days) from the date of issue of award letter by Demand Draft/Pay order to be drawn on any Scheduled/ Nationalised bank having its branch at Gangtok in favour of Director, Sikkim State Lotteries and lift the materials within 15 days thereafter.
 9. If the successful bidder fails to deposit the payment within the specified period, EMD will be forfeited.
 10. The tender committee reserves the right to selection/rejection of the bid without assigning any reason thereof.
 11. The jurisdiction to trial and entertain the disputes arising out of this tender shall be the competent court at Gangtok.
 12. The State Government may specify any other terms and condition that may deem fit and proper.
 13. The tenderer may seek the clarification / queries, if any, from the Office of the Director, Sikkim State Lotteries, Gangtok or the Office of DSSL, Kolkata.
