Bidders downloading the tender documents from the website will be required to deposit the tender fee of Rs. 5,000/- (Rupees Five Thousand Only) (non refundable) while submitting their bids. Bidders shall ensure that their tenders, complete in all respects, are submitted in the office of the Additional Director, NCD, Sikkim on or before the closing date and time indicated in Schedule of Events, failing which the tenders will be treated as late tender and rejected. The tenders sent by post/ courier must reach the above said address on or before the closing date & time indicated in in Schedule of Events, failing which the tenders will be treated as late tender and rejected.
