Original Bid Security amounting to ₹ 9,31,763.00 ( Nine lakhs thirty one thousand seven hundred sixty three) in the form of FDR / TDR from any Nationalised Bank within Sikkim / State Bank of Sikkim in favour of Additional Director (Accounts), Social Justice, Empowerment and Welfare Department, Lumsey, Tadong.
