NOTIFICATION

Whereas the State Government has deemed it expedient to frame rules for providing pension to the Unmarried Women in the State;

Now, therefore, the State Government hereby makes the following rules regulating grant of pension to the Unmarried Women namely:-

Short title and Commencement 1. (1) These rules may be called the Sikkim Unmarried Women Pension Rules, 2013.
(2) They shall come into force at once.

2. In these rules, unless the context otherwise requires:-

- (a) "Department" means the Social Justice, Empowerment and Welfare Department;
- (b) "Form" means the form appended to these rules;
- (c) "Government" means the Government of the State of Sikkim;
- (d) "Local resident" means a person belonging to either Bhutia, Lepcha or Nepali Community possessing Sikkim Subject Certificate or Certificate of Identification;
- (e) "Poor and Needy" means a person having no regular source of income of her own, no financial support from family members, Below Poverty Line Certificate holder and is non-recipient of any other pension from the State Government/Central Government or any other sources.
- (f) "Secretary" means the Secretary of the Social Justice Empowerment and Welfare Department;
- (g) "Unmarried Women" means a poor and needy women who has attained the age of 45 (forty five) and possesses unmarried certificate duly certified by the Competent Authority and till she attains the age of 59 years.

Amount of Pension 3. The amount of pension payable to each unmarried women shall be as such as may be notified by the Government from time to time.

Selection Committee 4. There shall be a Selection Committee for the purpose of selection other beneficiaries consisting of the following members namely:-

- (1) Secretary/Social Justice
Empowerment & Welfare Department -Chairperson.
- (2) Joint Secretary/ Social Justice
Empowerment & Welfare Department - Member.
- (3) Social Welfare Officer/ Social Welfare Division - Member.

*Cessation of Pension*⁵ (1) The unmarried women pension shall cease from the date of the death of beneficiary. The amount due up to the corresponding month of death shall be paid to the immediate members of the pensioner and the Passbook is to be surrendered to the Department.

(2) In case of permanent migration of the pensioner outside Sikkim, the pension shall cease to be payable from the date of other migration. In such event the family/ Panchayat of the pensioner shall surrender the pass book to the Department.

(3) In case the beneficiary enters into a marriage institution, the pension of the beneficiary shall automatically cease.

*Authority Competent to*⁶ The Authority Competent to sanction pension shall be the *Sanction Pension Secretary*.

*Procedure for Application*⁷ Application for pension shall be made in the form appended to these rules free of charge, along with (three) passport size photographs, Sikkim Subject Certificate or Certificate of Identification, BPL Certificate and Date of birth and unmarried certificate duly certified by the concerned authority.

*Procedure for*⁸ (1) On receipt of any application in the prescribed form the *Grant of Pension* Committee shall scrutinize the age, Sikkim Subject, Certificate/or certificate of Identification, Below Poverty Line Certificate etc. and after scrutinization of the complete documents, approval shall be accorded by the Secretary.

(2) A copy of the order for the grant and payment of pension shall be endorsed to the District Collector, Sub-Division Magistrate, Revenue Officer and Panchayat where the applicant actually resides and the applicant himself/herself.

*Payment of pension*⁹(1) The Secretary shall be the competent authority to make payment of pension.

(2) The pension shall be disbursed to the office of the Block Development Officer.

(3) The details of the pensioner/maintenance of accounts etc. shall be maintained by the Social Justice Empowerment and Welfare Department.

*Verification*¹⁰ If required, concerned officer of the Social Justice Empowerment Welfare Department shall make tour to village to verify the continued existence of the pensioner and other relevant particulars.

*Intimation of death of*¹¹ In the event of death of the pensioner, the family member/
the Pensioner Panchayat shall make report and also surrender the passbook to the Social Welfare Department, immediately.

*Penalty*¹².The authority competent to grant pension shall have the right to recover payments made on the basis of false or mistaken information, if any, about eligibility and death of beneficiaries.

Unmarried Certificate 13 The beneficiary shall produce unmarried certificate on yearly basis to check on the marital status of the beneficiary.
