NOTIFICATION

In exercise of the powers conferred by sub clause (i) of clause (d) of sub-section (1) of section 67 of the Motor Vehicles Act, 1988 (59 of 1988) and in supersession of all previous notifications on the subject, the State Government, hereby directs the State Transport Authority to revise the fares for Contract Carriages (Motor Cabs / Maxi Cabs), Luxury Tourist vehicles, Motorcycle rentals, Pakyong Airport taxi fares and Sightseeing Packages as per the rates given below with immediate effect.

Note:

1. The above enlisted fares of Local Taxis shall be increased by 50% from 10:00 PM To 04:00 AM for Local tours only.
2. Additional convenience fees of 10-15% shall be applied by the department on the above enlisted charges for online booking through Sikkim Cab app.
3. State Transport Authority shall notify the maximum fares to be charged by the Taxis
4. The Lean-season fares shall be 20% lower than the notified fares.

The following shall be the Operational Guidelines to be followed;

1. For any other destinations other than those listed in the fare charts, proportionate fare shall only be charged,
2. Additional Taxes/ Charges as per Central/ State Government norms shall be levied as applicable,
3. All Agent License holders and pre-paid ticket counters shall issue Ticket / Receipt to all passengers,
4. The Police Department and Tourism Department, or any other agency shall issue necessary permits to restricted/ protected areas only after furnishing of ticket / receipt of hire charges of vehicle at approved rates of the State Government,
5. Taxi drivers at all times should act responsibly and be courteous towards the tourist as per provisions of the MV Act & Rules,
6. Any taxi driver/ owner found guilty of indulging in any anti social activity/ alcohol / drugs will be dealt strictly as per the Act and Rules,
7. Any Taxi or Transport vehicles found charging fares in excess of the approved taxi fares, their permit shall be cancelled under section 86 (1) (a) of the Motor Vehicles Act, 1988,
8. Under section 74 92) of the Motor Vehicles Act, 1988, no driver shall refuse to carry passengers on hire, except in the circumstances of exceptional nature.
